

35th Annual MN Posse Wagon Train Registration Form

September 7th - 9th, 2018

Waseca County Fairgrounds

The 35th Annual Wagon Train for Youth sponsored by the Minnesota Sheriff's Posse Association will be held September 7th -9th, 2018 at the Waseca County Fairgrounds, Waseca, MN. The Wagon Train will be raising funds for Children's Hospitals and Clinics of Minnesota and \$1,000 will go to the Donald D. Eustice Memorial Scholarship Fund for an individual going into Law Enforcement.

The Wagon Train will leave daily from the Waseca County Fairgrounds and return each evening. The fairgrounds will be open for participants Thursday, September 6th at 4pm and will close Sunday, September 9th at noon. The ride will cover 15-20 miles each day, both Friday and Saturday. We recommend that horses be shod all the way around.

We will serve breakfast Friday, Saturday, and Sunday morning and lunch and evening meal both Friday and Saturday. Snacks will be available at each rest stop on the ride. You do not need a wagon to participate. Riders and saddled horses will follow the wagons- all horses (and mules!) are welcome. You should ensure that your horse is up to date on all vaccinations, with a current Negative Coggins test. Any unruly horses posing a significant safety threat will be asked to leave. Please ensure that all riders are appropriately matched to their horse. We strongly recommend safety helmets for all riders under the age of 18.

Please see Registration information below. It is very helpful to improve our ability to efficiently serve you! Registration fee includes parking & camping at the Waseca County Fairgrounds and meals as listed above.
